Welcome to February. For being the shortest month, February packs a lot of events—Valentine's Day, President's Day, Mardi Gras, National Margarita Day, and Groundhog Day. In addition, Cardinals pitchers and catchers report to spring training on February 12th and the whole squad on the 17th. The Blues are still in first place in the Central Division, but seem to have hit the post-All Star Game doldrums posting a 3-5-2 record over the last 10 games. Super Bowl LIV brought the Kansas City Chiefs their first championship in 50 years. Major

league baseball has adopted some new rules to speed up the game. Starting this season, pitchers must face a minimum of 3 batters or end the inning. This coupled with a change to the number of players on the roster (26 total vice 25, of which up to 13 can be pitchers) and a limit of 28 players on the September expanded roster, vs 40, will hopefully reduce the revolving door of relief pitchers in the late innings. In addition, the Cardinals and Cubs will be playing two games in London in June. Punxsutawney Phil did not see his shadow so early spring is on the way.

In line with our Property Owners' Association's Bylaws, we have a board of directors consisting of 9 members. Since we're a private, membership-only association, the board of directors is our equivalent of a small town's mayor, board of aldermen, and city manager, charged with the day-to-day operations and management of PVL as well as the long-range planning for improvements and capital expenditures.



Board of Directors Election

Every year, 3 of the board members' terms expire, meaning that members must vote for candidates to fill these positions. We know we have at least one retiring board member, so we need candidates who are willing and able to serve. To qualify, you must be a member of PVPOA, and current with your annual membership dues. Duties and responsibilities of board members include:

- Representing the interests of the membership of PVL
- Willingness to help with critical decisions affecting the lake and amenities
- Deciding on prudent use of membership dues
- Attendance at monthly board meetings
- Participation as an officer or on one or more committees

Board members are elected for a 3-year term on a rotating cycle. Meetings are the third Friday of the month, with an additional annual membership meeting in April. If you're interested in running for a board position, please click on the link at:

Pre-Lenten and Lenten Friday night Fish Fries run from February 14th through early April. In addition to the Owensville area events, for the last two years, we've been checking out various



fish fry events around the region in places such as Rich Fountain, Linn, St. James, Cuba, Gerald, and more. All are either at Catholic Churches or Knights of Columbus Halls, and sometimes the occasional Lions, Moose, VFW or Legion Halls. Some are all-you-can-eat (usually around \$11 per person), some are by the plate (usually around \$8 per person). Some offer just one type of fish, others offer fish and shrimp, and still others offer 3 or more types (catfish, cod, scrod, pollock, etc.).
