III. Election of Officers

VI. GUEST ISSUES:

Charlie Kinworthy brought up an issue with ruts in the campground. Tom Bush discussed his plan to put in a culvert and fill in a ravine to level out land between two camping pads.

VII. APPROVAL OF MINUTES:

X. COMMITTEE REPORTS:

A. OPERATIONS

1. Maintenance:

There was a question about getting the vegetation on the backside of the dam cut back and treated. Suggested using Roundup on the weeds, but need brush roundup for woody materials.

2. Security:

We have 5 people hired for security:

Note: Larry is also one of the maintenance team. He and the other two new security guards will work Sunday at 7 or 8 AM, and as needed other times. They'll be scheduled 7-3 on Memorial Day.

Charlie discussed taking pictures of non-members' boats/trailers, etc.

A reminder that 4th of July is on a Wednesday this year, meaning that the Lake will be particularly busy on the weekend before and after of the holiday.

3. Roads

We originally planned to replace 8 culverts, but ended up replacing only 7 and that work is done. We would also like to get the roads chipped and sealed in July. The roads to be done this season are West Forest from the lodge parking lot to Lake Shore Dr.; Lake Shore Dr. from West Forest to the road on the west side of the lodge, and Villa Vista from Circle Dr. to Lake Shore Dr.

Need to get the wooden boards replace on the docks near the lodge marina and on the sea wall near the dam.

4. Work Orders:

Would like to move the fire ring on campsite 12 to between campsite 7 & 8.

Need to repair door closer for the campground bathroom. \$30-60 for replacement

The picnic table at Campsite 9 needs to be replaced.

6. Maintenance Report:

B. LAKE

Floating algae is worst anyone has seen in a long time. Discussion about the use of liquid cultrine plus for algae control. Tom Eilermann, Gary Hacker, Mike Garlock, and Tim Edwards agreed to procure the cultrine plus and apply sometime the following week. .(Note: Tom et al., went out on Tuesday, May 22nd and sprayed 75 gallons of the chemical/water mix on about 1/3rd of the lake shore.

1. Boats:

2. Fish:

We're added 30 more grass carp in bringing the total to 120 that have been added to the lake within the last year.

3. Weed Control:

4. Dam:

80% of the back side of dam cut down and looking good. The worst part of the area near the cul-de-sac is done. Comment made that we should consider spraying down there to eliminate or retard growth.

C. MEMBERS FACILITIES:

1. Pool:

Pool cover was removed on May 9th with help from Tom Eilermann, Mike Garlock, Gary Hacker, Gary DeAngelis, Ray Oldfather, Glen Boettcher, and ??? (Ray's brother in law?). The pool level had gotten lower than expected and we scrubbed the waterline with water and muriatic acid. Having the cover on for the second season made it much easier to clean and get ready for summer. It took about a day to fill and it was reported that the pool chemistry is starting to get balanced.

The baby pool needs to be cleaned (note: Tim Edwards and Charlie Kinworthy did this on May 19th.

2. Campground:

Tom presented a proposal for Jarvis to place a culvert on a drain through the campground and then cover and level it. Estimate was ???. Gary moved to accept the bid, Kim seconded, motion carried..

3. Storage Yard:

Much of the junk has been removed, including the old camper. With the exception of one item, all members who were contacted to verify ownership of the items bearing membership numbers responded and wanted to keep the item in storage. The one exception has the number 93 on it, so we will contact all members with 93 in their membership number to verify ownership. We're going to wait after Memorial Day, when most people will have their boats out of storage and in the water, to start verifying VINs to start the next step in the process, which is to have the state verify ownership and then we can compare it to our membership rolls and then move to the next stop.

4. Beach:

Charlie will order sand for the beach. (Note: Two truckloads of sand were delivered and spread out about a week after the meeting)

5. Pavilions:

6. Tennis Court:

Crack filler and sealer was ordered to fill and seal the cracks in the asphalt in the court. Question about whether

June's event will be a "float-in movie"—we'll project a movie up against the Hacker house near the dam.
