2018 Annual Peaceful Valley Lake Property Owner's Member Meeting and BBQ April 27th, 10:00 AM-?

Mark your calendars!! The annual homeowner's association meeting is scheduled for Saturday, April 27th with registration and voting for the Board of Directors starting at 9:00 AM and the meeting starting at 10:00 AM at the PVL Lodge. This year there are 4 candidates for 3 board of directors' positions—see the article below for candidate profiles. We need at least 30 property owners to constitute a quorum. Immediately following the meeting will be presentation by the Public Water Supply District to bring Peaceful Valley members



up to speed on the lagoon project and the results of last summer's video inspection of the sewer lines. Afterwards, we'll provide lunch, along with drawings for gift cards and attendance prizes so mark your calendars and we'll see you there.

We're proposing that the dues remain at \$325, same as last year. We're also proposing a revision to the association's bylaws, primarily to allow us to use email, internet, etc., as an option to do association business. With postage now 55 cents for a first-

class letter, our annual dues mailing will cost us over \$350 just for postage alone. For those that opt to go paperless, we'll save not only postage but also the and administrative costs. Other revisions to the bylaws are to replace artifacts in the document from when the association was being developed in the early days.

Projects scheduled for this year include paving approximately a mile of roadway and replacing aging and rusting culverts under those stretches of road. Two years ago, we did Woodson and North Lea, and last year we resurfaced the roads from the lodge parking lot to the intersection with Lake Shore near the beach, and then Lake Shore from that intersection to the road on the east side of lodge. We also resurfaced Villa Vista Dr. from Circle Dr. to Lake Shore Dr., and added two disabled parking spots near the lower entrance to the lodge. This year we're going to focus on Lake Shore from the beach to the dam, and Peaceful Valley Rd. from the upper guard shack to Lake Shore.

Last year we upgraded the campground facilities by adding electrical outlets and water spigots at the most frequently used pads, as well as upgrading some sites to 50-amp service to accommodate today's larger RVs and campers. This year we've been extending and leveling several of the more popular camp site pads

We still need to repair the bridge at the lower entrance to the lake that was damaged a last year by a semi-truck. The bridge is structurally sound, but the guard rails are a bit loose and it's been difficult to find a contractor to come in and do the work. If anyone knows of a contractor that does concrete work like this, please call our office and let us know.

Based on the bridge incident, the board decided to install cameras at various locations around the lake So far, we've placed cameras near the maintenance shed, in the lodge, and at the burn pile and campground. We've purchased cameras to overlook the pool and the dam/boat ramp but are waiting for warmer weather to install those. Some of the cameras are portable so we'll be moving them to problem areas as needed.

One last item, we'll have representatives from Bluebit Networks, a local internet service provider that's interested in putting in high-speed internet at Peaceful Valley. The internet service they're proposing for Peaceful Valley is fiber-based and 10-15 times faster than Fidelity. The cost will be comparable to Fidelity's prices, but you won't need landline phone service to have internet like you do with Fidelity. We've talked to them about part-time subscriptions and pay-as-you-go plans for those members that are not full-time residents. addition, we've talked to them about offering internet at the campground and the marina for day users. If you're interested, please come early to talk to the representatives to learn about their service plans and offerings.

Nearby Restaurant Reviews: Brown Shanty Community Center 1378 Hartshorn Dr, Hermann, MO 65041

Friday, May 3rd marks the return of four consecutive Fridays of Fried Chicken and Pork dinners at the Brown Shanty Community Center just north of Bay, MO. Even though the address

says Hermann, it's only 21 miles away. Brown Shanty is a small lake development and twice a year in the spring and fall, the Property Owner's Association hosts this Friday night dinner for four consecutive Fridays from 4-8 PM. For \$11 per person, you fried chicken, get pork (different each week. but usually either BBQ pork

steak, pork loin, pork chops, etc.) mashed potatoes, corn, string beans, and a salad. One of the highlights is their fry bread served with honey butter. Drinks are available for an extra charge. Dinner is served buffet style and is all-you-care-to-eat or you can do a carry-out. The food is fresh and delicious as it gets pretty busy and hot chicken and

fry bread is constantly being refreshed.

From Owensville, you can take Highway P north to US 50. Go straight across 50 onto Highway K about two miles to Bay. Turn right on Hwy W for 1.4

miles to Brown Shanty Rd. on your left. It's a gravel road near the top of a hill and there's usually a "Fried Chicken Dinner" sign posted at the road. Take the road 2.5 miles and as you enter the development, take a left and the community center sits on top of a hill. There's an upper and lower parking lot. If you have mobility issues, you may want to park in the upper

lot. If you're using Google Maps, search for Brown Shanty and select "Brown Shanty Boulware Township" to get directions. Help support a neighboring lake development and have a good meal while you're at it.
